The Number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Indian Nursing Council/ KNRUHS.


The fee collected by what so ever name called either for University quota seats or for management seats should not exceed the limits specified by the State Government /KNRUHS from time to time.
